- 1.2 The legislative imperative is that the Reviewed IDP is presented for adoption as prescribed by the provisions of Section 34 of the Local Government: Municipal Systems Act, No 32 of 2000;
- That the Council approves the 2024/25 BPDM Reviewed IDP (Attached IDP as Annexure A);
- 3. That the District IDP Rep Forum was held on the 14<sup>th</sup> of May 2024 (Attached attendance register as Annexure B);
- 4. That the following Integrated District Wide Needs were submitted by the Local Municipalities:

Priority 1 - Water and sanitation

Priority 2 - Roads and Storm Water

Priority 3 - Local Economic Development

Priority 4 - Land and Housing

Priority 5 - Institutional and Sustainable Rural Development
